At 6:00pm Jessica Hatch opened the meeting.

At 6:00 Jessica motioned to go into nonpublic session per

Motion seconded by Ruby and passed unanimously.

At 6:15 Ruby motioned to come out of nonpublic session, seconded by Jessica. All in favor. No decisions were made, and no votes taken.

Ruby motioned to approve the minutes as amended, seconded by Jessica. Motion passed 3-0. The amendment changed the time students are on the bus from 1 hour 40 minutes to 2 hours 40 minutes.

#### **Building Permit Applications**

• 03-2023B Feinauer 262 Forbes Mtn Rd and across street/Ground mounted solar array. The homeowners will be digging a trench across the roadway and will need to obtain a Road Encroachment permit from the Town. Jessica made a motion to approve the building permit, seconded by Ruby. Motion passed 3-0.

#### **Old Business**

- The Board reviewed information regarding the realignment of New Canada Road that was approved by the Planning Board in a 2019 subdivision plan. No work has been done on this project. The cost of the road construction is estimated between \$125,000 and \$140,000. Jessica motioned to move forward with the paperwork and legal process of returning New Canada Road to the original layout. Motion seconded by Ruby and passed 3-0.
- Jessica met with Irene Reagan at her home, who has contacted the Selectmen's Office on two occasions this winter about the plowing of Chellis Drive. She believes it is not being done to the standards agreed upon by the Town. Road Agent Cornell also met with her regarding the maintenance of the road. At times there have been vehicles in the way of the truck turnaround. Ms. Reagan indicated to Selectwoman Hatch that everything is fine now.
