Jessica motioned to come out of non-public session at 9:43, seconded by James. Motion passed unanimously.

Jessica made the following motion:

We have received a Petition for the Removal of Land Use Board Member, John A. Taylor. The Board has seriously considered Mr. Taylor's actions, and the request that we take action to remove him from the Planning Board, including reviewing the request with our attorney. While we strongly disagree with the actions Mr. Taylor took with regard to the Deuink application and the Marchand appeal of that decision, we believe that it is best left to the voters to address those actions should Mr. Taylor seek re-election to the Planning Board when his term expires. Therefore, I move that we not take any action to remove him from office.

Motion seconded by James. Motion passed unanimously.

There was discussion regarding the reconstruction of Ragged Mountain Road from New Canada Road to Deckmans Road. As of April 30, the Road Construction Capital Reserve fund established strictly for this project, is \$135,380.42. In addition, another \$75,000 will be added to the fund in 2025 as approved by the voters in March. Ragged Mountain Resort owes \$25,000 for the road impact fee for the subdivision approved in 2024. A letter will be sent to RMR requesting an additional \$50,000 for road construction.

The Board will meet on May 28, 2025, at 6pm with the engineer for the project and a representative from Ragged Mountain Resort.

Also, the Board will meet Friday, May 23 at 6pm to interview a potential candidate for the Administrative Assistant position.

At 10:00pm Jessica motioned to adjourn the meeting, seconded by James. All in favor. Meeting adjourned.
