Lenny motioned to approve minutes as written, Anna 2nd, approved by voice vote.

New business:

Budget worksheet handed out by Jessica.

Highway:

Discussion ensued in regards to Road Agent wages.

Selectmen recommending an increase to Road Agent wages of \$3,000.00 from \$63,000.00 to \$68,000.00. Lenny motioned to increase the already approved budget committee amount for Road Agent wages of \$65,000.00 to \$68,000.00, Jessica 2nd, raise of hand vote taken, 3 in favor, 3 opposed, motion fails. Anna motioned to increase the already approved budget committee amount for Road Agent wages of \$65,000.00 to \$66,000.00, Doug 2nd, voice vote taken, 5 in favor, 1 opposed.

New total for Highway Executive changes from \$380,680.00 to \$381,680.00

New total for Highway Executive and Highway other changes from \$663,680.00 to \$664,680.00 Jim motioned to increase the already approved budget committee amount for Highway Executive and Highway Other of \$663,680.00 to \$664,680.00, Karen 2nd, voice vote taken, 6 in favor, zero opposed. Discussion ensued in regards to recent theft and trespassing at the Town of Danbury Highway property.

General Government Buildings:

Discussion ensued in regards to Maintenance and Repairs line.

Repairs needed to Library roof, window sills, front doors, chimney/roof flashing repair, insulation.

Chimney leaking issue at Town Hall.

Selectmen looking at security options at the Town of Danbury Highway Department building.

Discussion only, no votes taken.

Capital Reserves/Warrant Articles:

Discussion ensued in regards to individual lines and recommended changes.

Road Construction Capital Reserve:

Selectmen recommended \$75,000.00; Budget Committee recommended \$75,000.00

Highway Equipment Capital Reserve:

Selectmen recommended \$50,000.00; Budget Committee recommended \$50,000.00

(this amount may be moved to Highway Truck Capital Reserve; specifics of warrant article verbiage may require this change)

Bridge Funds Capital Reserve:

Selectmen recommended \$25,000.00; Budget Committee recommended \$25,000.00

Property Revaluation Capital Reserve:

Selectmen recommended \$7,000.00; Budget Committee recommended \$7,000.000

Building Capital Reserve:

Selectmen recommended \$23,000.00; Budget Committee recommended \$23,000.00

Lenny motioned to accept the Selectmen's Capital Reserve recommendation of \$180,000.00, Anna 2nd, voice vote taken, 6 in favor, zero opposed.

Town of Danbury Operating Budget:

Jim motioned to accept the Budget Committee's recommended increase of \$53,091.00 from \$1,555,075.00 to \$1,608,166.00, Lenny 2nd, voice vote taken, 6 in favor, zero opposed.

Total of \$1,608,166.00 does not include the previously voted on amount of \$180,000.00 for Capital Reserves/Warrant Articles.

Total Town of Danbury budget including Operating Budget (\$1,608,166.00) and Capital Reserves/Warrant Articles (\$180,000.00) recommended by the Budget Committee is \$1,788,166.00

Jim motioned to adjourn at 7:10 pm, Karen 2nd, verbal vote taken, all in favor.
