Capital Reserve:

Road Construction Capital Reserve:

Highway Equipment Capital Reserve:

Selectmen recommended \$50,000.00; Budget Committee recommended \$0.00

Jim motioned to accept Budget Committees recommendation in the amount of \$0.00, Lenny second, voice vote take, 6 in favor, 0 opposed.

Bridge Fund Capital Reserve:

Selectmen recommended \$25,000.00; Budget Committee recommended \$25,000.00

Jim motioned to accept Selectmen's recommendation in the amount of \$25,000.00, Anna second, voice vote taken, 6 in favor, 0 opposed.

Property Revaluation Capital Reserve:

Selectmen recommended \$7,000.00; Budget Committee recommended \$7,000.00

Jim motioned to accept Selectmen's recommendation in the amount of \$7,000.00, Lenny second, voice vote taken 6 in favor, 0 opposed.

Emergency Services Building Capital Reserve:

Selectmen recommended \$50,000.00; Budget Committee recommended \$25,000.00

Jim motioned to accept Budget Committees recommendation in the amount of \$25,000.00, Lenny second, voice vote taken, 5 in favor, 1 opposed.
