## **Appointments:**

  - Mark introduced himself to the board and discussed the Police Chief position currently open Marc has held many positions in law enforcement and may be interested in applying for the chief position. John Little was invited to the meeting, as a resident and former Police chief in New York, by Jessica to aid in meeting if needed.

#### **Old Business**

- Campers on 52 Danbury Woods Rd Letter to property owner regarding outhouses being out of compliance. Additional photos for review.
  - Photos reviewed "outhouse" is not in compliance with state requirements. Approved letter to be sent to owners.
  - o Cathy Chabot also discussed issues with ATVs being driven up and down Danbury Woods Rd.

#### **New Business**

- Email re: Defibrillators in Danbury Community Center Do we want Jeremy Martin to purchase needed parts to be billed to DCC?
  - Maggie has checked the defibrillator previously for expired parts. Holly will advise Jeremy, Fire Chief, to reach out to Maggie to determine if any parts are needed. No replacement parts will be billed to the fire department.
- Email re: Northern Rail Trail Will we be sending a representative?
  - Selectmen are unavailable to attend due to job commitments.
- Midstate Medical Center email re: Town appropriations request for Danbury residents
  - Jessica advised that Mid-State should be sending a formal letter of request to the Selectmen and the Budget Committee requesting funds
- Horizons Engineering water testing request
  - OK for testing to take place.
- Resignation from Road Agent Jeremy Cornell Information on filling position in the interim.
  - The Selectmen accept the resignation from Jeremy Cornell and thank him for his dedicated service.
  - The Selectmen are legally permitted to appoint an interim Road Agent to fill the vacancy. Holly will post Road Agent position. The selectmen will accept applications from 8/21 through 9/2. Applicant must be a Danbury resident.

#### Selectmen

- \$75,000 from Road Construction Capital Reserve Do we want to write a check to the town for these funds?
  - Yes, Holly will request the allotted funds from the trustees of the trust fund for the Ragged Mountain Rd Improvement Project.

- Comcast cancellation
  - Comcast account was discussed, and the accounts will be cancelled once we have determined that the fire department is no longer using the Comcast internet connection. Maggie will look into the internet connection.

#### Additional discussion:

- Hemlock Ln and if they have submitted a building permit for use of RV while home is being constructed. Holly stated that he has been advised that a permit is required. Also, use of incorrect address number has been addressed.
- *TAN payment Treasurer has paid the TAN in full.*
- Diane Blasotto spoke to selectmen about continued water issue with another resident.
- Updates to Ragged Mountain Rd contract with Phelps Construction adjustment to cost to account for paving. Paving to be completed with GMI directly. Holly was instructed to email Chris Huyler at Brown Engineering that Phelps Construction will begin work on 8/21/2025. Updated contract with Phelps Construction signed by Jessica Hatch and James Farmer.
- New Canada Rd easements signed by Jessica Hatch and James Farmer. Frances Bliss will sign at a later time.
