#### **Checks/Applications/Signatures**

- Payroll and accounts payable were signed
- Jim motioned to approve the minutes from 7/15, seconded by Lyn. Motion passed 3-0.
- Jim motioned to sign an amended vet credit application for the owners of 26 Searle Hill Rd 411-067-001 in the amount of \$200. Motion seconded by Jessica and passed 2-0.
- Jim motioned to sign a FD Purchase Order for the Active 911 subscription for \$260. Motion was seconded by Lyn and passed 3-0.
- Lyn motioned to sign the Tax Collector Purchase Order in the amount of \$1,554 for postage stamped envelopes. Seconded by Jim and passed 3-0.
- Jim motioned to sign and Intent to Cut for Lambert 201-104 Courtland Dr, motioned was seconded by Jessica and passed 3-0.
- Jessica motioned to approve a driveway permit for Gardner 411-088 on Ragged Mountain Rd pending Road Agent approval. Motion was seconded by Lyn and passed 2-0 with Jim abstaining.

- Jim motioned to enter into a contract for timber tax appraisal services with Matt Apgar of HHP Inc. Motion was seconded by Lyn and passed 3-0.

- The letter to the State of NH regarding the Hippie Hill citizen complaint was redone as it had been sent to the wrong person. All Selectmen signed the revised document.
- Someone is needed to install the door at the Town Hall that was purchased from Belletetes.
- The State of NH has not yet announced the grant awards for the broadband funds.

### New Business:

- Quote for replacement of steps at DCC. Lyn motioned to accept the quote of Reg Glines for the replacement of exterior stairs at the Danbury Community Center for \$1057. Motion seconded by Jessica and passed 3-0.
- The owner of Echo Glen lot 406-150 inquired whether he would be allowed to build a dry cabin for camping purposes as his property cannot support a septic system. The Board would like proof that the property cannot support a septic system.

#### Selectmen Items

- The new lock at the entrance of the transfer station is not being used to secure the entrance. Jim will speak with the employees on Saturday.
- The tractor pull organization will hold it's first event on August 15.
