### Checks/Applications/Signatures

- Payroll and accounts payable were signed
- Jim motioned to approve the minutes of 7/29 as amended for a word omission, seconded by Jessica. Motion passed 2-0.
- An "employee status notification" document for the Police Standards and Training document was signed for Police Officer Donald Sullivan's retirement.
- Jim motioned to sign an Intent to Cut for 44 Courtland Dr 201-105, seconded by Jessica. Motion passed 2-0.
- A Courtesy Notice letter for Castlegate Holdings, owners of 52 Danbury Woods Rd /408-067, was signed regarding building without a permit and camper placement on the property.
